### Definitions of Articles

### **Article:**

An object which during production is given a special shape, surface or design which determines its function to a greater degree than does its chemical composition.

# Requirements for SVHC





### **Definition**

- Substance of Very High Concern (SVHC)
  - CMR: Carcinogenic, mutagenic and toxic for reproduction







- PBT: Persistent, Bioaccumulative and Toxic
- vPvB: very Persistent and very Bioaccumulative substances
- Similar substances, e.g. endocrine disrupter







# 15 SVHC published in October

- Anthracene
- 4,4'-Diaminodiphenylmethane
- Dibutyl phthalate (DBP)
- Cobalt dichloride
- Diarsenic pentaoxide
- Diarsenic trioxide
- Sodium dichromate
- 5-tert-butyl-2,4,6-trinitro-m-xylene (musk xylene)
- Bis (2-ethyl(hexyl)phthalate) (DEHP)

- Hexabromocyclododecane (HBCDD) and all major diastereoisomers identified (α-HBCDD, β-HBCDD, γ-HBCDD)
- Alkanes, C10-13, chloro (Short Chain Chlorinated Paraffins)
- Bis(tributyltin)oxide
- Lead hydrogen arsenate
- Triethyl arsenate
- Benzyl butyl phthalate (BBP)

# **SVHC Basics**

- SVHC = Substance of Very High Concern
- REACH Definition
  - Substances on the candidate list for authorisation




### Details

- Additional responsibilities for preparations and articles containing >0.1% w/w of an SVHC substance
- SVHC need to be identified in MSDS documents
- Articles
  - Legal obligations of Article 33 and Article 7(2)
  - Communication obligations
  - Notification obligations
  - Plus industry related obligations (outside of regulation)





# Duty to communicate down supply chain - Article 33



- Inform customers minimum
- Chemical Name
- Information on safe use

Consumers may request information about presence of SVHC in articles (must reply within 45 days)





# Sample Letter Suggested by NGO

Date

Dear Sir/Madam

In accordance with the new European regulation on Chemicals, REACH, I am writing to ask you to inform me about the presence in the product XX or its packaging of any chemical from the group of "substances of very high concern" as specified by REACH.

Should any of these substances be present in the product XX or its packaging, I wish to be informed about the name of this substance, and receive sufficient information on how I can protect myself and the environment from it.

I would be grateful to receive this information within 45 days as required by REACH.

I would be grateful if you would inform me about steps you are taking to provide products intended for the same use but which do not contain such potentially hazardous chemicals.

## **Notification for Articles**


- If SVHC present in Article > 0.1% & amount of SVHC > 1 tonne/year, Notification is required.
- Volume is sum up of all products
- Time Frame:

SVHC before Dec 2010: by 1 Jun 2011
SVHC after Dec 2010: within 6 months after the inclusion

- Includes
  - Common letter to suppliers
  - Common REACH questionnaire to suppliers
  - Common schedule and deadlines

SVHC commitment (to be signed by supplier)










# Communication in supply chain

- Industry need to improve the communication through its supply chain
- Suppliers have to assist to provide information on substances
- Safety information communicated also to the downstream users & distributors
- Information include health, safety & environmental properties, risks, risk management measures
- Primary tool Safety Data Sheet (SDS) based on identified uses





# Supplier Declaration

- Difficult to demonstrate that supplier has the knowledge too many SVHC
- Likely to fail on supplier audit
- NOT a means to demonstrate due diligence
- Use in combination of chemical analysis if necessary, e.g. XRF or GC-MS screening






# **Authorization Requirement for SVHC**

**Ensure risks from SVHC are properly controlled or substituted** 

- SVHC only, ~1500 substances
  - -Applicant to show:
  - Adequate control of risks, or
  - Social and economic benefits outweigh the risks (no substitution)
- Applicant requires to analyse alternatives

### **REACH SVHC Assessment**



- Determine Client's REACH requirements detailing
  - Companywide responsibilities
  - Product-level responsibilities
- Determine Client's REACH position (i.e. manufacturer, importer, DU, formulator, etc)
  - Recommendation on EU status
    - Can Client take responsibility?
    - Should Client take responsibility?
- Review against definition of Articles
  - Determine risk of intentional release of substances
- Review candidate list of SVHCs
  - Review Product Information provided by Client
  - Assess areas of risk for SVHC substances
- Prepare Client REACH Positional Statement
- Determine dates/deadlines for product responsibilities
  - Assess long-term requirements such as Authorizations and possible Restrictions
- Overview responsibilities within the supply chain
- Strategy Guide and plan for SVHC Compliance





# **REACH SVHC Testing**

- Processing of product to create uniform sample for laboratory testing
- Laboratory testing and screening for SVHC chemicals applicable to product
- Testing report
- Assessment report



### **REACH Certificate**



### Product Checklist Review

- Review of client information against checklist requirements of either articles, preparations, or substances
- Corrective action report issued if additional compliance steps are required
- Creation of REACH Compliance Certificate
  - REACH Compliance Certificate issued to client for product/ substance based on all REACH requirements being met
  - Contact information for Intertek REACH team for Client customer verification of basis of compliance
