After the successful participation in **ISPO 2018** (**Munich, Germany**), we are now planning the Indian participation in **ISPO**, 2019 (**Munich, Germany**) which is scheduled to be held from Sunday  $3^{rd}$  February to Wednesday  $6^{th}$  February 2019.

#### Key highlights of the fair

- More than 80,000 visiting professionals from 120 countries came to ISPO MUNICH 2018.
- 2645 exhibitors presented innovative sports equipment and sportswear fashions on 180,000 square meters of exhibit space.
