Dear Sir/Ma'am,

With reference to our earlier mail of November 2021 informing you that due to the circumstances prevailing globally, Messe München had made the decision to hold ISPO Munich permanently in November end, leaving the previous January dates.

The SGEPC is organizing the participation in ISPO Munich 2022 to be held from November 28 to 30, 2022 (Monday to Wednesday). We would request the interested participants for ISPO 2022, to fill in the SGEPC online application form.

- In Indian pavilion (*Earlier Hall C4*), the minimum area that can be applied is 12 sq mtr.
- In any other hall, the minimum area that can be applied is **16 sq mtr.**

Cost of participation
